Participation in the development of the **adopted Law of Ukraine on improving the conditions of application of the green tariff for bioenergy objects**



2017

Participation in the development of the **adopted Law of Ukraine on stimulation of heat production from alternative sources** with application of tariffs at the level of 90% of gas tariffs



2019

Through joint efforts of UABIO and other organizations, the **«green» tariff is not reduced** for biomass and biogas electricity production facilities



2021

Participation in the development of the adopted **Law of Ukraine on the development of biomethane production**



Participation in the development of registered draft laws on the support for the cultivation of energy crops:

- regarding the **state support of growing energy crops**;
- on amendments to the Article 288 of the Tax Code of Ukraine regarding **the rent for land plots on which energy crops are grown**



2022

Participation in the preparation of the adopted Law of Ukraine on the improvement of **state regulation of digestate use**



Participation in the development of the **Procedure for the functioning of the biomethane register**.

Taking into account UABIO's proposals, the NEURC adopted a resolution to **simplify the requirements for oxygen content in biomethane**

Participation in the development of the adopted amendments to **the Customs Code on the export of biomethane**.

Participation in the development of the Order of the Ministry of Finance **on customs clearance of biomethane**.

Participation in the preparation of the Law on **the mandatory share of liquid biofuels in petrol and sustainability criteria for biofuels**.

Participation in the development of amendments to the GDS Code regarding **technical conditions for connecting biomethane production facilities**.
